

**CALIFORNIA PROPOSITION 65  
NOTICE TO ALL CALIFORNIA EMPLOYERS REGARDING OCCUPATIONAL EXPOSURE TO ODL  
PRODUCTS**

February 10, 2020

Dear Valued Customer,

All California businesses purchasing ODL products need to comply with California's Proposition 65 ("Prop 65") warning requirements, if your use of the products may result in the occupational exposure of your California employees to these products. Under Prop 65, "occupational exposure" means an exposure to any employee at his or her place of employment. Thus, occupational exposure may occur if your employees are using or handling ODL component products in the course of manufacturing a completed product, e.g., installing ODL door glass during the manufacturing of doors and windows.

Because ODL does not control the specific circumstances under which its products are used in an occupational setting, it is your responsibility as a California employer to make sure that any required Prop 65 warnings are provided to your employees. These warning requirements apply to the products listed in the attachment, because these ODL products may result in an occupational exposure to one or more Proposition 65 listed chemicals.

To comply with these requirements, you need to do the following:

1. Determine if your California employees may have occupational exposure to one or more of the products listed in the attachment.
2. If so, you must provide a Proposition 65 warning to your California employees in California who may have an occupational exposure.
3. The attachment provides you with the necessary warning materials that may be used to provide this notice. The notice should be given in all languages (English, Spanish, etc.) that you use to provide other hazard information to your employees.

Compliance with Proposition 65 warning requirements is very important, and there may be significant regulatory and legal penalties resulting from the failure to meet these requirements. Although we can't give legal advice about Proposition 65 issues, we are available to help you work through any compliance questions you may have.
